Sl. No.	The school is directed to ensure that:
1	The total number of sections of the school from class I to X shall be restricted to 38 out of which the school can run not more than 8 sections in secondary classes i.e. 04 in class IX and 04 in class X, subject to the condition that the school shall not run more than 1/4 of the total sections running in the school at any point in time at the secondary level. The optimum number of the students shall be restricted to 40 for a classrooms size of 500 sq ft and above. Further, increase of sections shall be subject to specific approval of the Board based on the request of the school as per affiliation bye law and availability of land and class rooms of greater than 500 sq ft dimension. 2	Boundary wall: The school has not covered the complete boundary wall of the school in videography. Hence, the school shall construct the boundary wall as per norms and shall submit the compliance with videography on saras portal within 3 months. The schools may refrain from using grills / mesh / small windows/gaps etc. upto the height of 6ft. Composite boundary walls which are partly concrete and partly grill/mesh/barbed wire below the height of 6 ft. shall not be acceptable. If fencing / grill is required then the same should be over and above 6 ft. of height.

3	The school shall appoint the staff as per Affiliation Bye Laws and maintain the section teacher ratio as per norms. The school shall also pay the Salary as per prescribed govt. norms to teachers and staff. The school will ensure it strictly.
4	The school has a basement. As per the SARAS manual, the use of basement in school for any kind of academic or sports activities is not allowed. Hence, the school shall ensure it strictly and submit an undertaking that the basement will not be used of any kind of academic or sports activities.

7	The school will ensure the Holistic Progress Card (HPC) is used for the foundational stage according to the guidelines issued by the Board via notification no. CBSE/Director (AcadAssessment)/2023 dated 27.12.2023.
8	The school shall submit an undertaking to upload all requisite information regarding students, teachers, and infrastructure details available in the school on the UDISE and OASIS Portals. The registration of the students in classes IX and XI shall be conditional on the school providing complete information on the UDISE and OASIS Portals.
9	The school shall conduct training of its teachers with COE Pune within 03 months and submit the compliance.
10	The school shall ensure that all teachers undergo at least 50 hours of Continuous Professional Development (CPD) every year, vide notification no. 16/2021 dated 24.09.2023, out of which 25 hours should be from COE Pune.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII, as the case may be.
